Approved Federal RESTART Terms:

Eligibility for this attraction / retention incentive is based on language approved by the federal government that states the following:

All district employees who worked to restart the school post-Camp Fire without a break in paid service at the Spring Valley School location between November 8, 2018 through June 30, 2020.

New staff members hired after the fire - after November 8, 2018 but before June 30, 2020 - will receive a sign-on / retention incentive should they remain employed, without a break in paid service at the Spring Valley School location through June 30, 2021.

A retiring certificated employee that qualified under the terms above asked to donate her incentive back to all of the employees eligible increasing the amount from \$4,285 to \$4,614.61.
